**Vendor Terms and Conditions:**

- The main event is scheduled for July 2nd from 4:30 pm to 10 pm. For reasons of safety, vehicles may not be driven within event grounds during event hours and until pedestrian traffic has left the grounds after the event. The scheduled rain date (fireworks only) is July 4th. Your fee includes a 20' X 10' space for one supply vehicle and 1 parking pass. Any vehicles other than your supply vehicle must be parked outside the event grounds in the general parking area and must display a parking pass.
- This vendor fee is for space only. You must upgrade to a sponsorship to receive sponsorship benefits. Vendors must provide their own tables, chairs and other equipment including shelter. Your Total Vending Fee must be paid in full before entering the event grounds. Electrical service and ice are available by request and only after your Total Vending Fee is paid. Fees are not refundable due to acts of nature such as weather. **We do not guarantee exclusivity for your product.** Vendors may not solicit outside of their designated vending space.
- Vendors are responsible for obtaining all necessary permits required by the State of Virginia and Bedford County, and meeting all governmental regulations. If your vending operation is shut down by inspectors, you will not receive a refund of any of the above fees.
- Please keep your space neat and clean during the event and bag and dispose of all trash in your space after the event. A dumpster will be provided. No pets are allowed on event grounds.
- Alcohol beverages may not be consumed outside of the designated drinking area. You may not bring alcohol beverages onto the event grounds. Items displaying profanity are not allowed.

Vendor agrees to indemnify and hold harmless the Saunders Volunteer Fire Company (SVFC), Smith Mountain Corporation, Marina Properties, LLC, and their respective owners, agents, employees and members for any liability, including legal fees and costs, arising from the Vendor's participation in this event. By signing this agreement, signatory certifies that he/she is eighteen years of age and has the authority to act on behalf of Vendor, and has read and understood the terms and conditions of this agreement.
