PURPOSE:

- The Extrication Team was established to increase the knowledge and abilities of firefighters in relation to safety, tool usage, and overall management of the motor vehicle accident scene with a minimum number of responders.

GUIDELNE:

1. All team members must have been in the department over one year and completed either Firefighter 1 or Fire Scene Support Operations.
2. The Extrication Team will train on a day other than Tuesday, as not to affect the regularly scheduled drills.
3. The actual team members will be selected three weeks prior to a competition based on the following criteria:
 - a. Number of Extrication Drills Attended
 - b. Number of Department Drills Attended
 - c. Number of Alarms responded to
 - d. Participation in Dept fund raising
 - e. If there is a dispute it will be decided by the Chiefs
4. Members will not be allowed to compete in more than 4 competitions unless the following criteria has been met:
 - a. There are no other qualified members to attend
 - b. The Member has changed job position such as:
 - i. Member to Captain
 - ii. Member to Medic
 - iii. Medic to Member
5. Maximum time a member may stay Team Captain is two years or four competitions.
6. Exception to 4 and 5 is if the Team has had a winning season and has been invited to a National or International Competition, then members may compete until the end of that season.
7. Team Captain will be selected by the Line Officers by ballot vote if there is more than one candidate and in case of a tie the Chief will make the final decision.
8. The Department will either provide transportation or reimburse mileage as per corporation policy.
9. The department will cover Entrance and Banquet costs along with necessary hotel rooms with a minimum of two members per room.
10. Finally Learn, Learn, Learn, and have FUN
11. Members will be reimbursed for meals as outlined in the corporate policy
