**A RESOLUTION AUTHORIZING THE DISPOSAL OF SURPLUS PROPERTY THAT IS NO LONGER

WHEREAS, Chesterfield-Hamilton Fire District #1 (District) is now in possession of certain tangible property that is no longer serviceable due to either age, condition or obsolescence, as more particularly identified on Schedule "A" which is attached hereto and made part hereof, and,

WHEREAS, it has been determined that the aforementioned items of surplus property no longer serve any public purpose and have no residual value; and,



2. The items of surplus property as listed Schedule "A" shall be deleted or otherwise removed from the Fire District's Schedule of Fixed Assets immediately upon their disposal.
