RESOLUTION PROVIDING FOR A MEETING NOT OPEN TO THE PUBLIC IN ACCORDANCE WITH THE PROVISIONS OF THE NEW JERSEY OPEN PUBLIC MEETINGS ACT, N.J.S.A. 10:4-12

WHEREAS, the Board of Fire Commissioners, Fire District #1, of Chesterfield and Hamilton Township, Burlington and Mercer Counties in the state of New Jersey is subject to certain requirements of the Open Public Meetings Act, N.J.S.A. 10:4-6, et seq; and

WHEREAS, the Open Public Meetings Act, N.J.S.A. 10:4-12 provides that an Executive session not open to the public may be held for certain specified purposes when authorized by Resolution; and

WHEREAS, it is necessary for the Board of Fire Commissioners, Fire District #1, of Chesterfield and Hamilton Township, Burlington and Mercer Counties in the state of New Jersey to discuss not open to the public certain matters relating to the items or items authorized by N.J.S.A. 10:4-12b and designated below:


- Matters required by law to be CONFIDENTIAL.
- Matters where the release of information would impair the right to receive funds.
- Matters involving individual privacy.
- Matters relating to collective bargaining agreements.
- Matters relating to the purchase, lease or acquisition of real property of the investment of public funds.
- Matters relating to public safety and property.
- Matters relating to litigation, negotiations and the attorney-client privileges.
- Matters relating to the employment relationship.
- Matters relating to the potential imposition of a penalty.
- Matters relating to the deliberation of administrative and/or quasi-judicial matters.
